Description: A 1949 graduate of the University of Alabama School of Law, Patterson was a veteran of World War II and the Korean conflict, and Alabama Attorney General (1954). Patterson defeated George C. Wallace in the 1958 governor's race and served a four year gubernatorial term. He ran for governor once again in 1966 and was defeated by Lurleen Wallace. Patterson also ran unsuccessfully against Howell Heflin for Chief Justice of the Alabama Supreme Court in 1970. In 1984 he was appointed to the Alabama State Court of Criminal Appeals, an elected office which he held until his retirement in 1997.

The John Patterson Papers consist of two cubic feet of documents from John Malcolm Patterson. The collection is comprised almost exclusively of c. 1950s materials from the Commission for Judicial Reform, including pamphlets, miscellaneous materials, letters, handwritten notes, and newspaper clippings.
